Notes:

- 1. Stranded conductor only.
- 2. Where a single cable is fitted in a conduit, only phase to earth voltage was applied.
- 3. When testing to BS 6387: 2013 Category CWZ, testing was conducted using a 20mm or 38mm stainless steel conduit. Either one or three conductors are tested, this is dependent on cable diameter. The conduit in all cases is connected to the neutral of the transformer.
- 4. The Firecel SR 112 cables met the requirements of IEC 60331-21:1999 when tested at a temperature of 750 °C for a duration of 90mins + 15mins cool down, at a voltage rating of 450V.
